

Notice About 2024 Tax Rates

Property tax rates in LaSalle County.

This notice concerns the 2024 property tax rates for LaSalle County. This notice provides information about two tax rates used in adopting the current tax year's tax rate. The no-new-revenue tax rate would impose the same amount of taxes as last year if you compare properties taxed in both years. In most cases, the voter-approval tax rate is the highest tax rate a taxing unit can adopt without holding an election. In each case, these rates are calculated by dividing the total amount of taxes by the current taxable value with adjustments as required by state law. The rates are given per \$100 of property value.

This year's no-new-revenue tax rate	\$0.453635/\$100
This year's voter-approval tax rate	\$0.464191/\$100

Voter-Approval Tax Rate Adjustments

State Criminal Justice Mandate

The LaSalle County Auditor certifies that LaSalle County has spent \$1,487,415 in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. LaSalle County Sheriff has provided LaSalle County information on these costs, minus the state revenues received for reimbursement of such costs. This increased the voter-approval tax rate by 0.000022/\$100.

This notice contains a summary of actual no-new-revenue and voter-approval calculations as certified by Dora A. Gonzales, LaSalle County Tax Assessor-Collector on 08/13/2024.
